Nature of Collaboration:

- c) Provision of expertise under Faculty Exchange Programme for the benefit of students.

1. Coordination and Contact Points:

The Head, Department of English of the College and the Head, Department of the Associate shall coordinate all activities referred in the MoU with prior intimation/correspondence/planning and provide required academic, technical and infrastructural support as per the necessity.

2. Responsibilities of the Associate:

The Associate shall:

- a) Provide academic, technical and infrastructural support required for collaborative academic activities.
- b) Provide expertise required for the successful organization of academic activities mentioned under proposed collaboration.
- c) Nominate faculty as the expert(s) under Faculty Exchange Programme and collaborative research activities.

3. Responsibilities of the College:

- a) Provide academic, technical and infrastructural support required for collaborative academic activities.
- b) Provide expertise required for the successful organization of academic activities mentioned under proposed collaboration.
- c) Nominate faculty as the expert(s) under Faculty Exchange Programme.

4. Period of Validity:

This agreement shall be initially valid for 05 years from the date of signing the memorandum of understanding i.e. **Saturday, 24th September 2022** and to be renewed subsequently by mutual consent of both the parties.


